

Quality policy – PDO & PGI



Outside wines, there were 1 169 products registered as Protected Designation of Origin (PDO) or Protected Geographical Information (PGI) in the EU at the end of 2014. The great majority of them (92%) are represented by agricultural products intended for human consumption, almost equally distributed between PDO and PGI.

The Member State with the highest number of protected products is Italy (with a total of 262 PDO+PGI products), followed by France (with 216 products) and by other Southern European countries (Spain 174, Portugal 124 and Greece 101) and Germany (with 78 products) [Table 4.24.9.1, 1/4].

The categories of products with the highest number of PDO or PGI are 'Cheeses' with 182 PDO, among which 46 from Italy and 45 from France, and 'Fruits, vegetables and cereals' with 198 PGI, among which 68 from Italy and 35 from Spain [Table 4.24.9.1, 2/4]

ORGANIC FARMING



EU certified organic and in conversion land area has increased in recent years, reaching more than 10 million hectares in 2012.

The largest areas were in Spain, France, Italy and Germany, but in Austria, Sweden, Estonia and the Czech Republic the share of total organic crop area out of total utilised agricultural area was the highest [Table 4.24.9.2-3].
